The debate in the Church of England

In 1962 the Church Assembly debated a paper, Gender and Ministry, CIO. This report recorded the opinion:

'We think that the various reasons for the withholding of the ordained and representative priesthood from women, reasons theological, traditional, instinctive, anthropological, social, emotional, should be much more thoroughly examined.'

This led to a resolution asking for a thorough examination of 'the various reasons for the withholding of the ordained and representative priesthood from women.'

A Commission was duly set up by the Archbishops of Canterbury and York 'to examine the questions of women and Holy Orders.' The Report Women and Holy Orders was published in 1966 (CIO) and debated in 1967. Following this debate a working party was set up to report on the position of women in ministry.

Women in Ministry: A Study, CIO, was published in 1968. Among its recommendations was one that the Church must ask and answer two questions: 'can women be ordained to the priesthood, and, what is the diaconate?'

The first meeting of the Anglican Consultative Council in Limuru, 1971, passed a resolution asking the churches of the Anglican Communion to consider the question of the ordination of women and to reply by 1973. A consultative document was prepared by Miss Christian Howard and presented to the General Synod of the Church of England, The Ordination of Women to the Priesthood, CIO, 1972.

In 1978 a supplementary report was prepared by Christian Howard, <u>The Ordination</u> of Women; A Supplement to the Consultative Document, CIO, 1978.

In 1984 a further report was prepared by Christian Howard concentrating on issues which had newly emerged or which had received fresh emphasis.

The Ordination of Women to the Priesthood: Further Report, CIO, 1984. This report was debated in the November 1984 General Synod. A motion was passed by the General Synod 'that this Synod asks the Standing Committee to bring forward legislation to permit the ordination of women to the priesthood in the Provinces of Canterbury and York.'
