There will be working sessions each day from 9.30 a.m. - 12.45 p.m. and from 4.15 p.m. - 6.30 p.m. with the exception of Thursday, 4th September. On this day there will be the Business Meeting of the Commission from 9.30 - 11.0 a.m., followed by a Nikaeen Reception from 12.0 - 1.0 p.m., and in the afternoon there will be a visit by coach to Avebury and Wantage for those who wish to go (for fuller details please see the Conference programme).


