

POSTSCRIPT: NB 36/2 (85) "Revised Pleshey Draft" should now be regarded as the definitive Pleshey text. It differs from the text issued from Pleshey by re-ordering the Church and Salvation material (Yarnold/Hill) into a more coherent draft (basically pages 4-7) and replacing the 'holding' conclusion (Durham material) by new work (Cameron/Thornhill).
